Legislative wins for 2023 The Veterans COLA Act (S. 777) and (S. 30) were signed into Law by Biden. S. 777 requires the VA to increase wartime disability compensation, clothing allowances for disabled veterans, and certain other compensations to increase with the cost-of-living increases. This will directly improve the quality of life for veterans and military families across the country! S.30 approves the construction of several VA hospitals and medical facilities and provides the budget to do so. There are still 12 bills to help our veterans to be brought up in the second session of the 118th Congress. 
## Poppy


